

Customer Appreciation Giveaway Official Rules

August 2023

1. Binding Agreement
 - a. By participating in this giveaway, you agree to be bound by these rules (“Official Rules”).
2. No Purchase is Necessary
 - a. NO PURCHASE IS NECESSARY TO ENTER THE GIVEAWAY. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.
3. Sponsor
 - a. ALTABANK, DIVISION OF GLACIER BANK, 33 East Main Street, American Fork, UT 84003.
4. Term and Agreement
 - a. Term
 - i. Entry into the ALTABANK’S Customer Appreciation giveaway starts August 4, 2023, and ends on August 11, 2023, at 11:59 p.m. Mountain Standard Time. ALTABANK’s computer is the official time-keeping device for the Giveaway. All entries must be received by August 11, 2023, at 11:59 p.m. MST to be eligible. Winners will be notified on or shortly after August 14, 2023.
 - b. Agreement
 - i. By submitting an entry, each entrant agrees to the Official Rules and warrants that his or her entry complies with all requirements set out in the Official Rules.
5. Eligibility
 - i. To be eligible for the giveaway, you must be a lawful permanent resident of the United States and a resident of Utah or Idaho. You must be over 18 years of age to participate. Giveaway void where prohibited by law. This Giveaway is void outside of Utah and Idaho. Employees of ALTABANK, officials, and members of their immediate families residing at the same address, are not eligible to participate in the giveaway. 6. How to Enter
 - a. Entry

 - c. Alternative Free Method of Entry
 - i. Participants can enter without making a purchase by mailing a legibly handwritten, self-addressed, stamped envelope with sufficient postage and a return address to: ALTABANK, 33 East Main Street, American Fork, Utah 84003. Include in the request, your email address, your telephone number, your full name and your desire to enter the giveaway no sooner than August 4, 2023 and received no later than August 11, 2023.
